



11th MAHARASHTRA STATE POLICE DUTY MEET-2013.

Medico legal (Oral) Test.

Instructions :-

Given below is the information in three parts. Study the information carefully for being questioned.

You may jot down the points but not allowed to make detailed note.

Part – I

On 15-11-2013, at about 08.00 AM, a milkman by name Raju came to your Police Station and informed that as usual he went to Flat no. 1, Shivam Apartments, Revenue Colony, Aurangabad at about 07.30 AM to deliver milk to Smt. Gauri Sakunde. But even after repeated pressing of doorbell, nobody opened the door. He then told this to watchman Pradip, who contacted Smt. Gauri on her mobile number but found switched off. Then they both knocked the door manually but nobody responded. So he came to Police Station suspecting some foul play.

Milkman also informed that he had delivered milk to Smt. Gauri yesterday and she, as a widow, stays with her daughter in law. Her son is in abroad.



Part – II

On your arrival at the spot, you opened the door latch with the help of duplicate key made by key maker and found the situation as below.

- 1) It is a small 1BHK flat. In the hall, body of Smt. Gauri lying on the floor in the pool of blood in the space between sofa set & TV showcase. Face of body towards roof, hands clinched.
- 2) Blood was oozing from right side of head above right ear. Only night gown on the body, No ornaments seen on body. Nicker (Panty) found intact on her body but bra missing. Conspicuous was her right nipple found cut.
- 3) She had been shot through the mouth and back of her head found shattered with exit wound. Blood and brain matter found spattered on the wall nearby the body and also on TV screen and showcase. Bloody fingerprints were visible on the handles of drawers of TV showcase.
- 4) Teapoy with glass top found in reverse position i.e. glass top touching the floor. One wooden leg of teapoy found broken and blood stained. Blood stains seen on teapoy at many places.
- 5) TV set found on showing religious songs with loud volume. Horoscope of Rahul, son of Smt. Gauri, seen lying on sofa set. The lights except in kitchen were on.
- 6) Medicine strip of Calmpose with 7 tablets in it found near TV set.



- 7) In bedroom, on the bed mattress naked body of Sudha, daughter in law, is seen. Face towards wall, legs straight. Night suit and bra seen on the floor in thrown condition.
 - 8) No ornaments on body. No blood or any other stain found on body or garments. No blood seen anywhere in the bedroom.
 - 9) Sudha's face appeared pale. Eyes open and eyeballs found prominent slight. Bloody froth coming out of flattened nostrils. Bruises and abrasions seen on nostrils, lips and at angle of mouth.
 - 10) Conspicuous feature was her left breast totally cut, scalp hair cut in the centre of head and pubic hair was also found cut. Panty found missing.
 - 11) A smell of formaline like chemical felt in bedroom, though no chemical found in the bedroom.
 - 12) Doors of steel Almirah in the bedroom found open with some items like clothing, jewellery boxes thrown on floor. Locker door of almirah open and two empty money purses with open zip seen on floor.
 - 13) Kitchen sink showed 2 empty tea cups and saucers with residual tea particles, steel utensil with sieve in it having brewed tea powder. One household plastic water bottle, half filled with 3 empty glasses seen on kitchen platform.

Part – III

Preliminary enquiry revealed that Smt. Gauri is a widow, being survived by only son Rahul. Rahul is in US as software engineer since 2 years. He got married in May 2013, for which he had come last time to the home availing 7 days leave. Mr. Sadanand, the late husband of Smt. Gauri was supervisor in private automobile company. He had died due to heart attack in 2012 November. Sudha was convent educated, fashionable girl from Mumbai. She did her IT engineering from the same college as that of Rahul.

They have not employed maidservant. Milkman Raju was the only person visiting them daily in the morning to deliver milk. Enquiry with the society residents revealed that this family was tight lipped and Smt. Gauri wasn't allowing anybody to come inside the home. They were not on talking terms with other neighbors except hello. They had never participated in any function arranged by the neighbors. No neighbor was invited for the marriage of Rahul.

One female neighbor reveled that sometimes she used to hear quarrels inside the home in female voices only with door locked from inside.

Watchman or residents revealed that they didn't have any information about the relatives of either Smt. Gauri or Sudha.

Inquiry with watchman transpired that yesterday evening deceased Smt. Gauri had told him that two male relatives of her would be coming at about 2200 hrs and he should allow them. He also revealed that two men, one young and other middle aged came at 2215 hrs, who told that they have come to see Smt. Gauri, so he allowed them. Both the men came by foot and wore monkey caps so he cannot describe facial features. They also told him not to close the entry gate of society as they might depart late and they will close the entry gate while they depart.
